當對-胺基聯苯(化學摘要號碼 92-67-1), 2-萘胺 (化學摘要號碼 91-59-8)或 2,4-二氨基苯甲醚(化學摘要號碼 615-05-4)被檢測出時,如果沒有額外的資料 說明(例如著色劑的化學結構等),被檢測樣品是否使用上述限制偶氮著色劑則 無法確認。

當試樣有 PU 材質時,例如 PU 泡棉、塗層或印花,無法排除部份苯胺如 4,4' - 二胺基二苯甲烷(簡稱 MDA, 化學摘要號碼 101-77-9) 跟 2,4-甲苯二胺(簡稱 TDA, 化學摘要號碼 95-80-7),可能源於 PU 釋出而不是限制偶氮著色劑。

萬一當顏料印花製程中一定要使 4,4'-二胺基二苯甲烷(簡稱 MDA, 化學摘要號碼 101-77-9),那麼 4,4'-二胺基二苯甲烷就可能不是源於限制偶氮著色劑而是來 自於化學固色劑。

中華民國標準 CNS 16113-1 L3280-1,會進一步將 4-胺基偶氮苯繼續還原,而 產出非限制物質的苯胺和1,4-苯二胺。因此,當苯胺及/或1,4-苯二胺的分析 結果是有數值時,則依照標準 CNS 16113-3 L3280-3 對 4-胺基偶氮苯的有無再 次確認。

偶氮的限制值,明訂於中華民國國家標準 CNS 15331 S2158 第 4.2.4 節。
